Co-contribution Fee:

A contribution to the cost of training and assessment must be made by students undertaking a certificate III level vocational qualification and non-concessional students undertaking certificate I and/or II level vocational qualifications. The fee may be paid on behalf of the student by a third party. Details of the co-contribution required are detailed on the Training Fact Sheet (RII30113 Certificate III in Surface Extraction Operations).

Foundation Skills and Lower-Level Vocational Qualifications:

Under the Certificate 3 Guarantee, foundation skills training (LLN) and lower-level vocational qualifications are also subsidised in certain circumstances, based on an individual's learning, skilling or support needs to achieve employment outcomes. These options will be discussed with the student after a LLN assessment and when developing an appropriate training and support plan.

Certificate 3 Guarantee Advices for Students:

1. Students will no longer be eligible for a government subsidised training place under the Certificate 3 Guarantee once they complete a certificate III level vocational qualification through the program
2. Students will be required to pay the appropriate co-contribution fee prior to commencing Certificate 3 Guarantee program, as per the Training Fact Sheet
3. Students will be required to complete a Student Training and Employment Survey within three months of completing or discontinuing the qualification
4. The *Apprenticeships/All Students Info – Self Service (AISS)* tool/search facility will be used to help confirm whether prospective students have previously attained a certificate III or higher-level qualification
